Bette and area neighbors worked hard last year to successfully defeat a proposed Liberty Lake zoning change for River District parks and the Farm from Residential to Open Space. By defeating this zoning change, we protected the intended leisure activities allowed in our beautiful parks and denied the placement of steel cargo containers in the parks and the Farm.
